Inventory Procedures

Inventory will be held for the debtor(s) to redeem for a minimum of thirty (30) days. Please have the debtor(s) contact the office for an appointment and quote on storage fees. Please allow 24 hours after repossession before retrieving personals.

Payments must be made at the time of pick-up and in cash. A valid photo ID will be required at the time of personal property retrieval and a release form must be signed by the debtor(s).

Vehicle Redemption Procedures

Please have the debtor(s) call the office to set up and appointment to redeem their vehicles, and confirm and redemption fees due.

A valid photo ID will be required at the time of redemption and a release form must be signed by the debtor.

All fees paid by the debtor must be done at the time of redemption and in cash
